May 9, 2013

Supervisor Fisk called the regular meeting of the Board to order at 7:00 p.m. Pledge of Allegiance was given. Pastor Brad Reynolds from Crossroads Worship Center gave the invocation.

PUBLIC COMMENT: Public Comment was given

NEW BUSINESS:

Trustee Bill Smith commented on previous meeting election concerns brought up by a resident.

Motion: Approve consent agenda consisting of April 11, 2013 regular Meeting of the Board minutes, Treasurer's Report, Police report, fire report, zoning report, library reports and the monthly bills. Motion by Sholty, second by Stevens, Ayes: 5 Nays: 0, motion carried.

Motion: Correction on agenda item #6 to change direction on Tamarack from West to East of County Line. Motion by Smith, 2nd by Stevens, Ayes: 5 Nays: 0, motion carried.

Motion: Approve contract to machine wedge & seal Lake Montcalm Road from Amy School Rd. west to end of pavement, sharing obligation with Pierson Township, Reynolds Township portion being \$16,285.00. Motion by Sholty, second by Smith Ayes: 5 Nays: 0, motion carried.

Motion: Approve contract to machine wedge & seal Tamarack Rd from Maple Hill Rd. west to Amy School Rd. for \$28,589.00. Motion by Smith, 2nd by Stevens, Ayes: 5, Nays: 0, motion carried.

Motion: Approve contract to machine wedge & seal Maple Hill Rd. from M-46 south to Almy Rd. for \$22,000.00. Motion by Stevens, 2nd by Smith, Ayes: 5, Nays: 0, motion carried.

Motion: Approve contract to machine wedge Almy Rd. from Federal Rd. East to Paepke Rd. for \$8,680.00. Motion by Smith, 2nd Sholty, Ayes: 5, Nays: 0, motion carried.

Motion: Approve saving \$10,000 this year and next year from road budget fund and work with Pierson Township doing the same and start upgrade of Lake Montcalm Rd. from freeway West to County Line as a shared project with Pierson Township next summer. The road would still remain a dirt road. Motion by Sholty, 2nd by Smith, Ayes: 5, Nays: 0, motion carried.

Discussion on the uncertified portion of Tamarack Road East of County Line. Road Advisory Committee will present to the Board 3 bids and more discussion will take place at next monthly Board meeting.

Motion: To discuss further Township Assessment Record cards. Assessor Dennis Wright will be in attendance at the next meeting to discuss further and inform residents. Motion by Sholty, 2nd by Stevens, Ayes: 5, Nays: 0, motion carried.

Clerk Robin Sholty presented facts and figures regarding General Election and Deputy Pay.
