

REYNOLDS TOWNSHIP BOARD MEETING MINUTES

7.9.20

Supervisor Kindel called the regular Meeting of the Board to order at 7:00 pm., Pledge of Allegiance was given.

MEMBERS PRESENT: Supervisor Kindel, Clerk Sholty, Treasurer Stedman, Trustee Eversole and Trustee Saucier.

CONSENT AGENDA: Mark Stevens presented the Zoning Report

Motion: Approve consent agenda consisting June 11 2020, Regular Meeting of the Board Minutes, Police Report, Fire Report, Zoning Report, Treasurer's Report, and the Township's Monthly Bills. Motion by Saucier, 2nd by Stedman, Ayes: 5, Nays: 0, Motion Carried.

OLD BUSINESS:

Tax Account still has excess money, filing cabinets will be ordered. Treasurer noted he is collecting summer tax.

NEW BUSINESS:

Clean up Day was over budget, with cleanup costs and numbers compared to last year.

Motion Adopt Resolution #R2020-0709-01 Adjust Budget, transferring \$4713 from 265-970 Capital Outlay to 840-950 Clean Up Day. Motion by Eversole, 2nd by Stedman. Roll Call Vote: Stedman – Aye; Sholty – Aye; Kindel – Aye; Eversole – Aye; Saucier – Aye. Resolution Declared Adopted.

Several Zoning Violations and discussion on how to address those issues.

Discussion on Elections, extra supplies needed due to Covid and payment to church for polling place was never addressed. Motion: Pay First Baptist Church of Howard City \$200 per election for the use of their facilities. Motion by Saucier, 2nd by Sholty, Ayes: 5, Nays: 0, Motion Carried.

Discussion regarding new Township Hall regarding grants and loans available.

Treasurer having rescheduled medical procedure and will be unavailable for tax collection beginning July 16th. Note will be posted and on website. Taxes may be paid at the bank or put in the drop box. Arrangements for mail & drop box to be picked up for home delivery have been made.

BOARD COMMENTS:

Supervisor Kindel thanked Trustee Saucier for building door on the Treasurer's office.

Clerk Sholty noted statutorily, tax monies may not be touched by the Clerk as a separation of duties is mandated.

Trustee Saucier noted he trimmed brush and weeds from around the township, questioned Treasurer regarding over \$18,000 in tax account as of June 30, as compared to minimal

amounts from other townships who have around \$500, and offered to take care of township trash.

PUBLIC COMMENTS:

Commissioner Ron Baker noted Board of Commissioners is having upcoming budget meetings. Candidate Tom Ginster running for 64B District Court introduced himself.
