Supervisor Kindel called the regular Meeting of the Board to order at 7:00 pm., Pledge of Allegiance was given.

MEMBERS PRESENT: Supervisor Kindel, Clerk Sholty, Treasurer Stedman, Trustee Saucier, and Trustee Eversole.

CONSENT AGENDA: Motion: Approve consent agenda consisting of October 8, 2020 , Regular Meeting of the Board Minutes, October 19, 2020 Special Meeting of the Board Minutes, Fire Report, Zoning Report, Treasurer's Report, Township's Monthly Bills, and Library Report. Motion: Reappoint Jason Lund to Planning Commission for 1-year term. Motion by Sholty 2nd by Saucier, Ayes: 5, Nays: 0, Motion Carried.

Making progress on storage issues at the Township Hall and Offices.

Election laws are changing every day. All ballots mailed go through the Grand Rapids post office. There is an injunction against counting absentee ballots postmarked Nov. 2 through November 14. Extra workers are in place. A normal absentee ballot count for an election is around 300. Thus far 907 ballots have been issued with 328 being returned. Clerk Sholty stated "I am a 1000% honest clerk and every ballot received will be counted!"
