Contracts will be coming in the near future.

NEW BUSINESS: Burial rates have not been increased in approx. 7 years. To keep in line with other townships and avoid a large increase, a rate increase of \$50 has been proposed. Resident Burials April 1-Nov 5 will be \$450, Cremation \$150, Winter burials Nov. 16-March 30 will be \$600, Cremation \$200, Saturday Burial - \$50 additional fee, Sunday Burial - \$150 additional fee. Foundation charges are 30 cents a square inch, with a two-inch border. Motion: Approve burial increases. Motion by Sholty, 2nd by Bergstrom, Ayes: 5, Nays: 0, Motion Carried.
