NEW BUSINESS: Amend current 2014-15 budget - Resolution #R2014-1009-01 for Audit from the current \$3,100 to \$3,650 due to additional research on fire and safety millage. Highways, Streets & Bridges from the current \$112,481 to \$117,781 due to oversight of monies approved in May 9, 2013 meeting for a shared road project with Pierson Township on Lake Montcalm Rd. not being added to current budget. Brining from the current \$16,000 to \$19,584 due to approval of 4th application of chloride to gravel roads approved in May 8, 2014 Township Board Meeting. Motion by Sholty, 2nd by Smith, Roll Call Vote: Smith: Aye, Fisk: Aye, Stevens: Aye, Sholty: Aye, Absent: Kindel, Resolution #R2014-1009-01 declared adopted.
