Supervisor Dan Fisk called the regular meeting of the Reynolds Township Board to order at 7:00 p.m. Pledge of Allegiance was given. Pastor Brad Brillhart of Heritage United Methodist Church offered the invocation.

NEW BUSINESS:

Motion: To Approve Consent Agenda. Motion by Treasurer Stevens, 2nd by Trustee Kindel, motion approved.

Motion: To Approve Land Division/Combination Application. Motion by Clerk Sholty, 2nd by Treasurer Stevens, motion approved.

Motion: To Approve Township Committee Application. Motion by Trustee Smith, 2nd by Trustee Kindel, motion approved.

Motion: Resolution for future Planning Commission/Zoning Board of Appeals appointees to serve voluntarily, with reimbursement for expenses to be approved by the Board. Motion by Stevens, 2nd by Kindel. Roll Call: Stevens-aye, Smith-aye, Kindel-aye, Fisk-aye, Sholty-aye. Ayes: 5 Nays: 0. Resolution adopted.

Motion: Resolution for new fee structure to reduce fees charged to residents for Zoning Permits, Applications to the Planning Commission, and Zoning Board of Appeals meetings, from \$450 to \$200 with zoning permits issued free of charge. Motion by Treasurer Stevens, 2nd by Clerk Sholty. Roll call: Fisk-Aye, Smith-aye, Sholty-aye, Stevens-aye, Kindel-aye. Ayes: 5 Nays: 0. Resolution adopted.

Motion: Approve 90-day extension to the terms of the settlement with Dale Cass. Motion by Clerk Sholty, 2nd by Treasurer Stevens, Motion carried.

Mark Christensen of the Road Commission introduced himself and spoke on the road commission policy and asked for an appointed liaison from the Board.

Board Comments: Clerk Sholty made comment fire extinguishers have not been checked since 2007 and will be bringing those up to code.

Supervisor Fisk commented on openings to the Planning Commission and Zoning Board of Appeals. Trustee Bill Smith commented that as a Board, we plan to work with residents and local businesses.
